TERMS & CONDITIONS

This contract authorizes **ONE CENT AUTO REPAIR & SALES** to make a vehicle purchase on your behalf. Due to time sensitive opportunities, we will make the decision to purchase your vehicle based on the criteria specified on this contract. If we feel that there is a need to contact you with any questions (for example, we need to verify the criteria outlined, or, we've found another make/model that may interest you), we will make every effort to do so.

ONE CENT AUTO REPAIR & SALES will perform a general inspection on the vehicle prior to our purchase of it. General maintenance items cannot always be determined at the time of acquisition and may not be discovered without a more thorough inspection upon your request.

All terms of vehicle sales are final and the vehicle is sold as is. Any used vehicle, even if thoroughly inspected, may have unforeseen mechanical failures arise after purchase. Such is the nature of used vehicles and we hold no liability should this occur.

You, the Customer, must have the monetary means available to purchase the vehicle and have payment ready *prior* to any purchase made by **ONE CENT AUTO REPAIR & SALES**.

CANCELLATION CLAUSE

A great amount of time and money may be incurred by **ONE CENT AUTO REPAIR & SALES** in order to find the right car, at the best price, to satisfy your needs. Should this contract be voided at your request, one of the following conditions will apply.

If Contract is cancelled *PRIOR TO VEHICLE PURCHASE:*

Once this contract is signed, if for any reason you should change your decision to use the *Auto Brokerage Services* of **ONE CENT AUTO REPAIR & SALES**, and a vehicle purchase has NOT yet been made on your behalf, a cancellation fee of **up to \$250.00** will be assessed. This fee is determined by the length of time that we have committed towards the research and exploration of locating your desired vehicle.

This fee will automatically be charged to the credit card on file unless other arrangements are made.

If Contract is cancelled *AFTER THE VEHICLE IS PURCHASED:*

Once this contract is signed, if for any reason you should change your decision to use the *Auto Brokerage Services* of **ONE CENT AUTO REPAIR & SALES**, and a vehicle purchase HAS already been made on your behalf, but not yet paid for by you, the following fees will be assessed:

- 15% of the Vehicle Purchase Price
- Any monetary loss in the reselling of the vehicle
- Any Auction Buy/Sell Fees, if applicable

These fees apply as a nominal reimbursement of our time, expenses and losses incurred.
